- The Board's directives regarding the strategy for the years 2022 to 2024 were reviewed and ensured that they were implemented.




Financial Performance – YTD 30 Sep 2022





Financial Performance – (Q3-2022)






Comprehensive income attributable to owners of the Bank








Financial Position – 30 Sep 2022
